Narrative

Violation of a Family Violence Court Order H. Savage 115
01/17/2019
G19-03400

On 17 January, 2019, at approximately 6:00 P.M. I Officer Savage responded to 303 Ethridge Drive in reference to a violation of a family violence court order. Upon arrival I spoke with the victim, Terra Morgan, whom stated her soon to be ex-husband, Kyle Morgan has violated the conditions of their Family Violence Protective Order that was set by a Magistrate Court Judge of Glynn County.

Terra stated her and Kyle had a court date on 15 January, 2019, where the judge issued an extension of 12 months to Terra's protective order. On Terra's order I observed a subsection stating that Kyle shall not; interfere with any of Terra's travel, transportation, or any forms of communication. Terra is alleging that on today's date between the time of 1:00 P.M. and 6:52 P.M. Kyle had suspended her Verizon Wireless Cellular service. Terra stated in December she had made a report with SGT. Melendez (150) in reference to a stalking incident and mentioned to SGT Melendez that Kyle had taken away Terra's right to view their online Verizon account. Terra stated she had attempted to contact Verizon to see why she was no longer able to view their account, and Terra stated the Verizon representative stated she was not able to disclose any information to her as she had been removed from the account. Terra stated the Verizon account holder is Kyle and no one else would have the access to approve any changes to their account except for Kyle.

On today's date Terra realized she was not able to receive any incoming telephone calls or text messages, and was also not able to make any outgoing calls or send any text messages. I observed Terra attempt to call and receive calls to the effected cellular line all attempts with the above stated line were unsuccessful. Terra verified within the general settings of the cellular phone that the number of the phone was indeed the number that was effected. A screen shot photograph of the Verizon Account showing Terra's suspended access and telephone line has been added under this case.

After gathering Terra's statement, as well as being briefed on previous incidents between Kyle and Terra, it was determined that Kyle did violate the stipulations of their Family Violence Protective Order. Terra provided information of Kyle's whereabouts as he was either at work or his residence in Nahunta. Kyle was located at his place of employment at the Jekyll Island Hotel on Jekyll Island.

Upon speaking with Kyle, I informed him the reason I was making contact with him, is due to Terra alleging he altered their cellular telephone plan. Initially Kyle stated he did not suspend her line, and that he could show me on his Verizon App. on his cellular telephone. Kyle was unsuccessful in showing me

any details of Terra's cellular line on his Verizon App. I further asked if Kyle would be willing to contact Verizon's 24 hour customer service line to show, when, and who suspended her line to show it was indeed not Kyle. Kyle stated he attempted a Verizon customer service number but was unsuccessful. I again stated that Verizon does have a 24 hour number he could reach, at that point Kyle stated "he wished to speak with his lawyer" in reference to these allegations. I did not further question Kyle about the incident. I placed Kyle in handcuffs, checked them for tightness, and double locked them. I advised Kyle he was under arrest for violating a stipulation in his and Terra's Family Violence Protective Order. I searched Kyle prior to being placed in the rear of my patrol vehicle, nothing was located. I transported Kyle to the Glynn County Detention center where I transferred custody of Kyle to the Glynn County Sheriffs Office. Officer Body Camera footage has been uploaded under this case, as well as a copy of the Protective Order.
